We are closely watching the advice of national organizations as they work to begin horse shows and events and will work to see if our fall horse trials will be able to take place and how other events are changing to reduce potential spread of covid-19.

Our camp organizers have made the tough decision to cancel our traditional ABC and D Camps in June. We will be working to see what type of lessons and/or activities might make sense for members as the group setting of camp is not going to be feasible as originally scheduled.

Because we know many members are interested in schooling at the field and disappointed that we will not have our spring rallies and horse trials,

Debby Price is working with our cross country course designer from our horse trials to have jumps placed at Bittersweet so our members can school. Bittersweet is currently closed but our plan is to reopen on May 30th with jumps out for members. The Potomac Hunt is going to mow the field before handing it over to our club for the rest of the year, and the farmer renting from the Kiplingers will move the herd of sheep currently grazing where members ride. We will have an online sign up for members wishing to use the field to school so we can monitor the number of people at the field. Watch your emails for the online sign up form and details on any restrictions state and local government may place on activities.
